## REPRESENTATIVE TOWN MEETING

The RTM is Darien's nonpartisan legislative body. Members are elected from the town's six voting districts on a proportional basis. The RTM has a limit of 100 members.

The RTM conducts six annual meetings regularly. In addition, the Moderator may call the RTM into special session. Each member of the RTM serves on a standing committee. Two members from each district serve on the Rules Committee, which determines procedural matters. The Moderator of the RTM is elected annually and chairs the RTM.

The RTM passes laws and ordinances, votes on whether to approve expenditures that have been approved by the Board of Finance, approves collective bargaining contracts involving town employees, and acts on the town budget.
